





COMMON MARITIME AGENDA FOR THE BLACK SEA 2021 - COORDINATION OF THE REPUBLIC OF TURKEY

REGIONAL WEBINAR: BLUE ENTREPRENEURSHIP WORKSHOP FOLLOW-UP ON BUSINESS ECOSYSTEM SUPPORT 04 OCTOBER 2021 (14:30-18:10 GMT+3) ONLINE

On 25 May 2021, under the Turkish coordination of the Common Maritime Agenda for the Black Sea (CMA), a Regional Webinar was organised on 'Research and Innovation (R&I) towards cultivating the potential for Blue Entrepreneurship'. The event was held in cooperation with the Strategic Research and Innovation Agenda (SRIA) for the region and the Black Sea CONNECT project.

The aim of the event was to strengthen the links between the implementation of the Common Maritime Agenda for the Black Sea and its scientific pillar, the Black Sea SRIA. This is a necessary first step towards assessing the R&I needs of priority sectors (which were defined during the last Regional Stakeholders Conference of the CMA held on 10 December 2020) and accelerating SME capacity through a fully sustainable blue economy in the Black Sea region.

A number of challenges emerged during the discussion, including needs:

- for better knowledge of the marine environment to enable the sustainable development of maritime activities;
- for additional support to business innovation through the full adoption of 'circular' business
- for stronger data-sharing and the full uptake of innovation potentials offered by the digitalisation of the sector.

Participants also acknowledged that the business ecosystem across the Black Sea region still lacks the essential capabilities needed to take advantage of the opportunities provided by innovative business models available across the blue economy. Therefore, the increasing appetite for private investments in a sustainable blue economy across the Black Sea region remains unmatched due to the limited expertise of local SMEs to either adopt such innovative technologies and business models or pitch their innovation projects to investors and financing institutions.

More recently, a number of initiatives have been promoted by the European Commission to address such challenges, all in line with the Common Maritime Agenda's Goals and Priorities. These include notable Horizon 2020 projects such as BRIDGE-BS and DOORS aimed at fostering research and innovation capacity and business-research dialogue for a sustainable blue economy across the Black Sea.





Fully aware of such a dynamic context and with the aim of triggering concrete advancement on project ideas while ensuring strong synergies amongst existing activities, this webinar will discuss the concrete challenges and opportunities of the blue economy business ecosystem, while focusing on a dedicated project hackathon session. During the first semester, CMA National Hubs supported Black Sea stakeholders in the definition of projects contributing to CMA goals and objectives. During the hackathon session, these project ideas will be presented by potential lead partners and discussed with potential donors or sponsors. Short concept notes will then be published on the BSAM website and disseminated to the potential donors or promoters who will be asked to provide further feedback. To build upon existing initiatives, potential valuable project ideas will also be discussed.

Participating SMEs and start-ups will have an unprecedented regional opportunity to pitch their ideas and interested regional stakeholders will be invited to join their efforts, supporting them to capitalise on previous experiences.

Therefore, the overall question to be addressed across each session of this webinar is the following: "Given all the activities ongoing in the region, how can the CMA, SRIA and related implementation projects further support local business ecosystems – i.e., by strengthening potential synergies across ongoing activities and addressing relevant persisting gaps?"
