

# BRIEF DESCRIPTION OF THE COMMON MARITIME AGENDA FOR THE BLACK SEA

## Unlocking the potential of the Blue Economy in the Black Sea

The Common Maritime Agenda (CMA) for the Black Sea is a regional cooperation initiative within the Black Sea Synergy. It promotes collaborative solutions for a sustainable blue economy, fostering regional dialogue and maritime projects while preserving the marine environment.

Established by the 6 participating countries (Bulgaria, Georgia, Moldova, Romania, Türkiye and Ukraine) and supported by the European Commission, the CMA is a unique cooperation framework, reinforcing regional dialogue between countries and stakeholders to jointly address challenges and opportunities of the blue economy sectors in the area. Complementing the CMA, the Strategic Research, and Innovation Agenda for the Black Sea (SRIA) contributes valuable scientific insights for informed decision-making.

Through the CMA, the Black Sea region aligns itself with other two EU sea basin initiatives, in setting a basin-wide initiative for blue growth based on the sustainable use of maritime and marine sectors.

The European Commission has set up the Black Sea Assistance Mechanism (BSAM) to support the implementation of the Common Maritime Agenda (CMA) for the Black Sea.
